COMPETITION RULES

- 1 **Competition:** The competition shall be for a set of 6 digital photographs.
- 2 **Guidelines:** Sets may be diverse in subject matter or based on a theme. Images should flow naturally from one to another (e.g. subject, colour, format) to form a coherent and visually pleasing set.
- 3 **Number of Entries:** Entrants may enter **one** set of 6 digital photographs.
- 4 **Exposure Date of Entries:** Images may have been taken at any time.
- 5 **Eligibility:** Any photograph previously used in a set receiving an award in this competition is not eligible.
- 6 **Presentation:** **Digital** images must be sized, named and saved in accordance with the following guidelines:
 - Size images to a maximum of **1024 pixels** wide and **768 pixels** high.
 - Images must be saved in **JPEG** format.
 - Embedding a colour profile is recommended (for viewing on monitors this is usually **sRGB**).
 - For identification and sorting purposes, image files must be **named** as follows: DS ID [space] Title (eg: DS123 Winning Image.jpg)
 - **Label your CD or USB Flash Disk** with your name **OR**
 - **Email your entry** to competitions@greymouthphotoclub.org.nz.

Each set of should conclude with one final 'summary' image (a 7th image) consisting of six 'thumbnail' images of the six individual photographs within the set. This image should be a maximum of 1024 pixels wide and 768 pixels high and have a black background. The purpose of this 7th image is for visual reference during the judge's summarizing comments of the set as a whole.

- 7 **Titles:** It is recommended that individual images are titled. The overall set may be titled if so desired.
- 8 **Judging:** A judge known to be competent in judging sets of photographs shall be selected and he/she shall be given a copy of these rules with the entries. In arriving at their decision, the judge shall take into account subject matter, set cohesion, visual presentation, and the general feel of the set, but they may use any method they wish to determine the result. The judge shall comment on each set as a whole and may include brief comment on individual images if they wish.

9 **Awards:** **The Davison Salver** shall be awarded for the best set of 6 photographs. The winner shall receive a certificate and be entitled to hold the salver for one year.

Second and Third places shall also be awarded, the recipients each receiving certificates.

Highly Commended places shall be awarded at the judge's discretion, but shall not comprise of more than 10% of the total number of entries. The recipients shall each receive a certificate.

Merits shall be awarded at the judge's discretion, but shall not comprise of more than 10% of the total number of entries. The recipients shall each receive a certificate.

10 **Points:** Points shall be given for photographs gaining the awards listed in Rule 9 and will count towards the member's total points in the Aggregate Points competition. The value of points shall be:
